The book offers an in-depth account of the form, focusing on how the split allegiances of its component genres allow for the unleashing of radical energies.

The Crimean War in the British Imagination, Cambridge University Press, September 2009.

The Crimean War in the British Imagination considers the British literary and cultural response to the Crimean War (1854-56). Before Britain entered into full-fledged war for the first time in forty years, the nation had, in the words of Matthew Arnold, been "wandering between two worlds, one dead, / The other powerless to be born." The Crimean War served as a midwife to the age. I consider how mid-Victorian writers and artists reacted to an unpopular war: one in which home-front response was conditioned by an unprecedented barrage of information arriving from the East in letters and images from private and public "war correspondents." This history had formal consequences. How (for example) does patriotic poetry translate the blunders of the Crimea into verse? How does the shape of literary heroism adjust to a war that produced not heroes but a heroine, Florence Nightingale? How does the predominant mode of journalism affect artistic representations of "the real"? I show how the war created and crystallized trends in cultural development even as contemporary reactions to the war were guided by expectations shaped by literature and art.

The Crisis of Action in Nineteenth-Century English Literature. The Ohio State University Press, 2006.

The Crisis of Action, my first book, examines the relationship between Aristotelian categories of action and character in nineteenth-century English poetry and prose. The age was obsessed with its lack of what Matthew Arnold calls "great human actions." In looking at writings from the period, I explore some of the historical reasons for this obsession, such as the failure of the French Revolution, crises of faith brought on by scientific discoveries, laissez-faire government, and the increased role of women in the literary sphere. By emphasizing the importance of inaction—that is, both frustrated action and internalized action—in nineteenth-century literature, I demonstrate a connection between Romantic poetry and the Victorian novel of consciousness. The book was awarded the Samuel and Ronnie Heyman Prize.
